Public Hearing Conditional Use Permit– Residential Use in Commercial Facility

The proposed conditional use is to build a building with one floor for commercial use (2401 square feet) and one floor for residential use (2401 square feet). The subject property is located at 100 N Ash Street, Parcel #0311058080600 described as LOT6 BLK8 ORIG-BNGN NESE; 30-3-11 W.M., Klickitat County, Washington. The zoning of the subject property is Commercial. The adjacent zoning is Commercial on all sides.

Public Hearing Conditional Use Permit - Chiropractic Office, 205 W. Jefferson
